

OFFICIAL RULES & REGULATIONS

NO PURCHASE NECESSARY TO ENTER OR WIN.

1. **ELIGIBILITY.** The Science ATL Sweepstakes (“Sweepstakes”) is open to legal residents of (and who are physically present in) the State of Georgia who are 18 years of age or older at the time of entry. The following are ineligible: employees, officers, and directors of Science ATL, Inc. (“Sponsor”) and their spouses and immediate families (parent, child, sibling, and any of their respective spouses) and household members (whether or not related).

The Sweepstakes is governed by Georgia law and is subject to all applicable laws and regulations. By entering the Sweepstakes, participants agree to accept and be bound by all terms of these Official Rules. Void where prohibited or restricted by law.

2. **HOW TO ENTER.** To enter the Sweepstakes, eligible participants (“Participants”) must mail one of the Sponsor-provided postcards (or a postcard/letter created by Participant) (each an “Entry”) with a brief description, drawing, or doodle, along with a few words describing where Participant would go and what Participant would do, if science could take the Participant anywhere. Participants should keep all entries simple. This is NOT a contest and sending Sponsor elaborate or lengthy Entries will not increase Participants’ odds of winning. Winner is selected at random. See Section 3, below, How to Win for more details. Parents/guardians may submit an entry on behalf of their child, but all Entry information must be the parent’s/guardian’s information. Do NOT submit any personal information relating to a child.

Participants may enter the Sweepstakes beginning on **January 24, 2023** until **March 27, 2023** (“Entry Period”). Entries must be postmarked no later than **March 27, 2023** and submitted in the name of an individual person, and prizes will only be awarded to the person whose name is on the winning Entry. Proof of submitting an Entry does not constitute proof that Sponsor received the entry in the Sweepstakes.

False or deceptive acts or entries, or entries generated by script, macro or other automated means will be void, will render a participant ineligible, and also may result in participant no longer being allowed to enter Sponsor’s sweepstakes, contests or other promotions in the future, at Sponsor’s sole discretion. Entries must be submitted in the name of an eligible living person and the prize can only be awarded to the person whose name is on or corresponds to the winning Entry (or, if none, the primary email address associated with the email identified, as applicable). The authorized account holder is deemed to be the natural person who is assigned to the email address associated with the email by the relevant entity responsible for assigning the email address for the relevant domain.

The Sponsor and its respective employees, officers, directors, representatives and agents (collectively, the “Released Parties”) are not responsible for misdirected, incomplete, lost, late, illegible, undelivered, inaccurate or delayed entries, or for technical, hardware, or software failures of any kind, lost or unavailable network, cable, satellite, Internet service provider, telephone, telephone lines or other connections, preemptions, blackouts or any other acts beyond Sponsor’s control, failed, incomplete, garbled or delayed computer transmissions, failures of the US postal service, or any other errors or problems of any kind which may limit or affect a person’s ability to participate in the Sweepstakes, whether human, mechanical, typographical, printing, electronic, network or otherwise, relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prizes or

in any Sweepstakes-related materials. In the event of sabotage, war, acts of God, terrorism or threats thereof, computer virus, or other events or causes which corrupt or undermine the integrity, administration, security or proper operation of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify entrants and/or modify, cancel or suspend the Sweepstakes. In the event of termination of this Sweepstakes, Sponsor reserves the right, in its sole discretion, to award the prizes from among all non-suspect eligible entries received up to the time of such action.

3. HOW TO WIN; ODDS OF WINNING:

On or around **April 10, 2023** the potential winner (when verified by Sponsor as set forth below, the “Winner”) will be randomly selected by Sponsor, from among all eligible entries received during the Entry Period. The odds of winning will depend on the total number of eligible entries received. The Winners will be notified by Sponsor via email and must meet all eligibility requirements including timely replying to Sponsor’s notification and executing and returning all necessary releases and documents (if any) required by Sponsor. Winning a prize is contingent upon fulfilling all requirements set forth in these Official Rules.

In the event of a dispute as to the identity of a Winner, the Sponsor will resolve the dispute in its sole discretion.

At the sole discretion of Sponsor, disqualification may result from any of the following: If the potential Winner (i) fails to respond to the notification or contact Sponsor within the time specified in Sponsor’s email notification to the potential Winner, (ii) fails to sign and return all necessary documents within the time period designated by Sponsor, (iii) declines the prize, (iv) fails to provide Sponsor with satisfactory proof of age, identity and residency, or (v) fails to comply with any of the Official Rules as outlined herein, such potential Winner will be disqualified and an alternate Winner will be chosen.

The decisions of Sponsor in all matters regarding this Sweepstakes are final and binding.

4. PRIZE. “National Park” means one of the following US National Parks: Yellowstone, Grand Canyon, Glacier, Zion, Death Valley, Mount Rushmore, Rocky Mountain, or Yosemite.

5. **GENERAL.** By participating in this Sweepstakes, participants grant the Sponsor the right, unless prohibited by law, to use the participant's name, voice, picture and likeness, and biographical information, without compensation, further notification or approval, for the purpose of advertising and publicizing the goods and services of the Sponsor and all matters related to the Sweepstakes, in any manner or medium, throughout the world in perpetuity.

6. ARBITRATION/CLASS ACTION WAIVER: PLEASE READ THIS SECTION CAREFULLY – IT MAY SIGNIFICANTLY AFFECT YOUR LEGAL RIGHTS, INCLUDING YOUR RIGHT TO FILE A LAWSUIT OR CLASS ACTION IN COURT.

Any dispute/claim relating to this contract or its breach, the Official Rules or any prize awarded ("Claim"), that is not informally resolved within fifteen (15) days of notice, shall be finally resolved by arbitration in the State of Georgia. The arbitration will be administered by the AAA under its AAA Rules, will be conducted in English and by a single arbitrator, and any court with jurisdiction may enter judgment regarding the arbitrator's award.

The Sponsor will bear the cost of any arbitration filing fees and arbitration fees for claims of up to Seventy-Five Thousand US Dollars (\$75,000.00 USD), unless the arbitrator determines that the arbitration is frivolous. Participant is responsible for any other costs that he/she may incur in the arbitration, including, attorney fees and expert witness costs, unless the Sponsor are otherwise required to pay such costs under applicable law. Participant may pursue his/her claim in small claims court where jurisdiction and venue

over the Sponsor is proper if Participant's claim otherwise qualifies for such court and Participant does not seek any equitable relief.

The parties agree that the Sponsor and Participant will resolve any Claim on an individual basis, and that any Claim will be brought in an individual capacity, and not on behalf of, or as part of, any purported class, consolidated, or representative proceeding ("Class Proceeding"). The parties further agree that neither will participate in any current or future Class Proceeding brought by any third party relating to the Official Rules, Sweepstakes or any prize.

If any court or arbitrator determines that the class action waiver is void or unenforceable or that arbitration may proceed on a class basis, then the relevant claim will not be subject to arbitration and must be litigated in federal court located in Atlanta, Georgia.

The agreement to arbitrate and class action waiver also apply to any Claims that Participant asserts against the Sponsor or its contributors or sponsors, or their respective present or future parent, subsidiary or affiliated companies.

7. PRIVACY POLICY: Any personally identifiable information collected during participation in this Sweepstakes will be used by Sponsor solely for purposes of the proper administration and fulfillment of the Sweepstakes as described in these Official Rules.
